Internal Call for Posters

“Migration, Integration and Social Justice in Europe”

Over the last few decades, questions concerning the governance of immigration and integration have become ever more pressing across European countries and European Union institutions. The development of restrictive immigration policies, constraining people's access to European territory and proceeding to a selective distribution of rights according to migratory status, has profound impact on the lives of migrants trying to settle in European societies. Meanwhile, issues regarding the management of religious, linguistic, and ethnic diversity are not limited to immigrant minorities, and the access to rights is often constrained by economic inequality and social (in)justice even more than by issues tied to legal status.

We invite NGOs, local associations, institutions, international organizations, scholars, and activists to consider becoming part of this conversation by submitting a poster proposal exploring various aspects of migration, integration and social justice.

Poster submission general guidelines

We encourage submissions of posters addressing, but not limited to, the following themes:

- Identity and cultural integration.
- Citizenship and political participation.
- Labour and social Integration.
- Urban integration residential patterns and mobility.
- Refugees fleeing to Europe.

Posters provide a venue for authors and organizations to present work in progress reports, projects on original work that seeks to advance our current knowledge in any of the topics listed above. Posters are evaluated on the basis of originality, promise, and contribution to the conference program.

Please note that

- Poster session presenters will not be reimbursed or compensated for presentation time, mileage or any other expense related to their participation in the conference.
- Contact information and registration to the conference is required to attend the poster session.
- Displays will be exhibited on the three days of the conference in one of the cloisters of the University of Deusto, Bilbao.
- Set-up time will be on **Wednesday July 6, 2016**, between 9:00am and 14:00pm.
- Provided at no charge for poster exhibitors will be one standard panel, but presenters must bring their own pins, tacks, or other material to mount their display board.
- Displays should be visually appealing (charts, diagrams, graphics, illustrations etc.) and clearly state the purpose of the display.
- Presenters should bring any handouts or other supplementary materials and a sign-up sheet to record names and email addresses of attendees who may like additional information.
- Neither the University of Deusto nor the conference organizers can be responsible for materials, equipment or personal belongings left at your exhibit.
